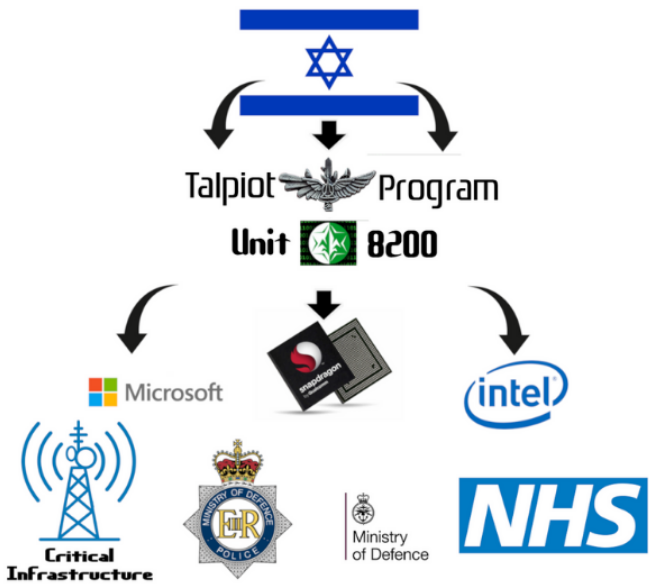

HOLD A PARLIAMENTARY VOTE ON WHETHER TO REJECT AMENDMENTS TO THE IHR 2005

The Amendments to the International Health Regulations will permit the World Health Organization to:

- DECLARE A HEALTH EMERGENCY BASED ON ARBITRARY INFORMATION
- CREATE A GLOBALISED DATABASE OF HEALTH DATA COMPROMISING PRIVACY
- SET UP A PHEIC (PUBLIC HEALTH EMERGENCY OF INTERNATIONAL CONCERN) FUND DEMANDING AROUND 35 BILLION POUNDS MORE OF TAXPAYER MONEY
- REMOVE RESPECT FOR HUMAN DIGNITY AND INDIVIDUAL FREEDOMS AND REPLACE IT WITH EQUITY
- SUPPORT GAIN-OF-FUNCTION RESEARCH
- MAKE CURRENT NON-BINDING RECOMMENDATIONS INTO LEGALLY BINDING OBLIGATIONS
